Daily water supply system status updates: Wednesday, 8 March 2023 (Morning)

Water supply status update by exception (i.e., areas affected due to supply constraint and not service interruption from occasional pipe burst).

Unplanned interruptions:

Johannesburg Water Customer Notice: Power interruption at Rand Water's Zuikerbosch purification plant impacts pumping from three pump stations

The power failure at Rand Water's Zuikerbosch purification plant is impacting the pumping capacity from Zwartkopjes pump station by 20%, Eikenhof pump station by 20% and Palmiet pump station by 75%. Technicians have been dispatched to attend to the problem.

The reduction in supply will affect Johannesburg Water infrastructure in Midrand, east of Johannesburg, south of Johannesburg, and the Commando system (Brixton, Crosby and Hursthill). Johannesburg Water is monitoring infrastructure affected and will be providing customers with further updates.

Johannesburg Water requests customers to reduce consumption during this period.
